## 1. Dedicated Fee Status Advisor

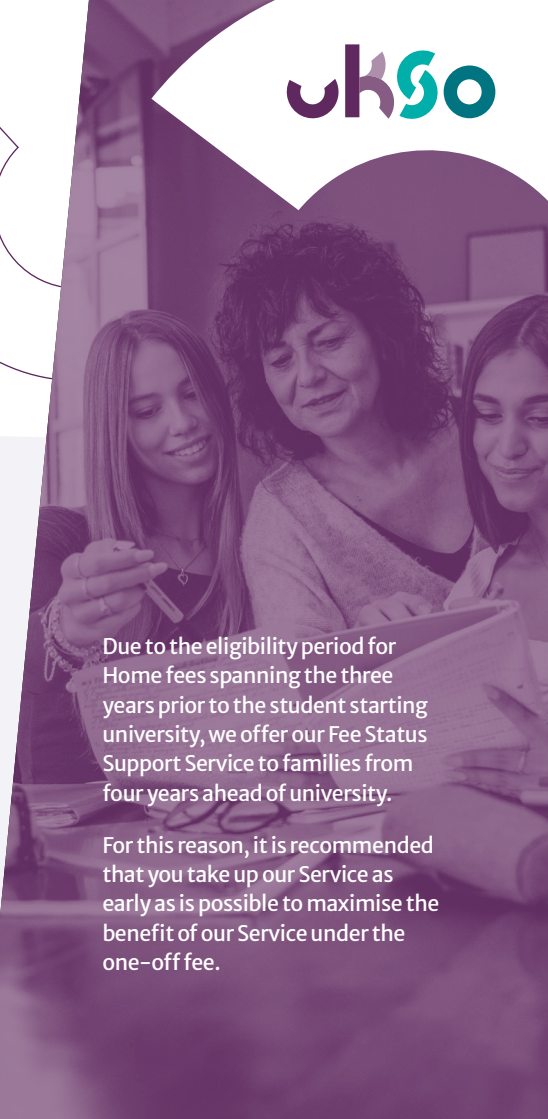
##### Post Application Support

Due to the eligibility period for Home fees spanning the three years prior to the student starting university, we offer our Fee Status Support Service to families from four years ahead of university.

For this reason, it is recommended that you take up our Service as early as is possible to maximise the benefit of our Service under the one-off fee.

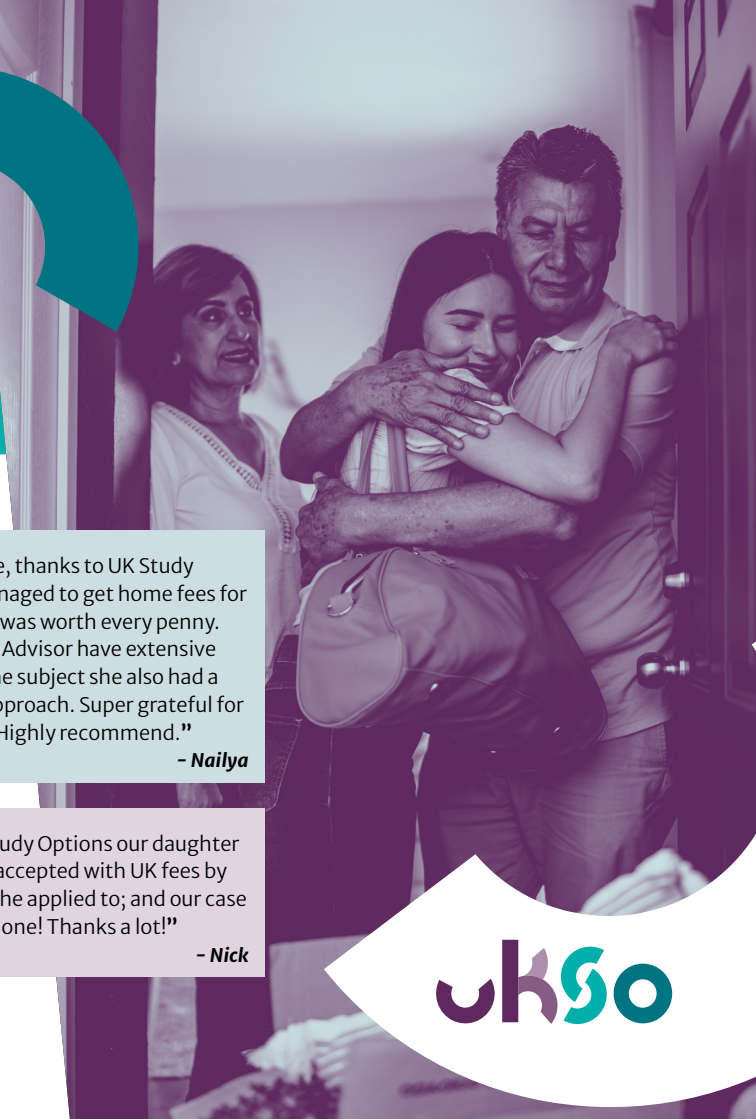
